FOREIGN TRAVEL GUIDELINES

- Each country is rated from A-E. Locate the country or countries the applicant is traveling to.
- Use the grid to match the country or countries and number of days the applicant travels per year to find the appropriate underwriting class. If multiple destinations, decisions will be based on the riskiest location.
- Certain states have laws restricting underwriting for lawful foreign travel, and we comply fully with those laws.
