



Foreign Travel Guidelines

Effective August 12, 2019.

Replaces previous version dated March 24, 2017.

The following charts define how American General Life Insurance Company and The United States Life Insurance Company in the City of New York assess travel to various countries around the world.

¹ Except where noted, extended travel (greater than 6 months) will be considered on a case-by-case basis and may be underwritten as a residency case under our Foreign National guidelines. In addition, extended travel (greater than 6 months) outside of the U.S. or Canada will require facultative reinsurance if over our internal retention.

PRODUCT AND COVERAGE AMOUNTS

- All life insurance plans are available.
- Autobind up to \$41 million on Term and \$60 million on Permanent
- Jumbo Limit to \$65 million
- Individual Consideration for long-term travel (greater than 1 year)
- Individual Consideration for amounts over \$20 million, age greater than 70, rating greater than Table D.

Important Notes:

- Diplomats, embassy employees or missionaries assigned to a C, D or E country generally will not be considered for coverage. Missionaries assigned to A and B countries, and individuals taking short mission trips (21 days or less) to A, B, C or D countries will be considered.
